TCC GO participants will learn what options might be the best fit for their interests and how to pursue them. While TCC GO focuses on encouraging students to enter a health-related field, our academic advisors and staff will work with students to develop a plan regardless of their career interest.

Who should apply to TCC GO?

- Alaska Native students interested in getting a head start on their career or college/technical program of study.
- Students that are college ready and prepared to meet the challenges of dual credit courses.
- Students interested in exploring various career options.

How to apply?*
