<u>Scope</u>: Establish contracted Traditional Healing Services for victims of crime

- (A) Tanana Chiefs Conference, Tribal Government & Justice Division invites qualified and experienced Alaska Native traditional healers and/or other non-Western allopathic healers to provide contracted 'Traditional Healing Services' to TCC Tribal Protective Services (TPS). Traditional Healing Services will provide complementary, traditional and healing services to referred clients within the Tanana Chiefs Conference (TCC) region. TCC client who are eligible and referred by TCC Tribal Protective Services will be able to access traditional care as well as Western medical system care to integrate all aspects of health, physical, mental, emotional and spiritual health.
- (B) Tanana Chiefs Conference, Tribal Government & Justice Division invites qualified and experienced Alaska Native traditional healers and/or other non-Western allopathic healers to provide contracted 'Educational and Instructional Services' pertaining to traditional healing, including during TCC sponsored healing gatherings in Fairbanks and/or TCC Region villages. Education and Instructional Services will assist TCC Tribal Protective Services in bringing awareness and outreach to TCC clients, tribal governments, providers, and employees on the use of traditional healing services and teachings of traditional foods and plants as natural medicines to help support all aspects of health in harmony with all other health services including western science and medicines.

The selected traditional healers may propose contracted projects/services in one of both scopes (A/B), contracted services may include:

- Traditional Healing Services, i.e. Healing Touch, Healing Hands, REIKI, Cranio Sacral Therapy, Tui Na, cupping, reflexology, sound healing articular Acupuncture, Talking Circles, guided meditations, breath work, other cultural activities that bring healing etc...
- Proposed Presentations for Healing Gatherings sponsored by TCC
- Healing Gathering Facilitation and/or breakout facilitation sponsored by TCC
- Traditional Healing Instructor during Education/Outreach TCC events
- Traditional Healing Instructor for education videos, white papers, of other technical writing developed in partnership with TCC
- Traditional Healers mentorship/apprenticeship projects



The tribal contractors will be expected to provide deliverables upon completion for proposed projects, such as, but not limited, to the following:

- Client Intake demographics and Patient Experience evaluation reports for traditional healing services provided
- Presentation proposals, including PowerPoints and/or other developed training materials
- Facilitation proposals, including agendas, scopes of proposal, supplies and inventory lists, facilitation strategies including community, youth and elder engagement
- Powerpoints and/or curriculm materials for any presentations, education/outreach, and/or training materials
- Traditional Healers mentorship/apprenticeship curriculm/framework proposals, strategy for implementation, and a process for certifying apprentices that complete curriculm

<u>Term</u>: Contracts awarded will begin on October 1, 2023, and end on September 30, 2025. TCC will have the sole option of extending the award up to two additional fiscal years. TCC is accepting proposals on an on-going basis, and contract start dates will be effective once a proposal and contract is approved and signed, following the procurement procedures of TCC.

<u>Selection Process</u>: Tribal practitioners will be selected through a competitive and fair process based on receiving a responsive bid that meets the most qualifications indicated below.

<u>Note</u>: All tribal practitioners selected are required to comply with Alaska Native and American Indian Preference in accordance with Public Law 93-638 and the Family Violence Prevention and Indian Child Protection Act. Preference will be given to applicants living in one of the Tanana Chiefs Conference's villages.

<u>Solicitation and Proposal Rejection</u>. TCC reserves the right to cancel this solicitation, reject any proposal and award the Contract to the bidder(s) that provide the best overall value, which may be determined by factors other than the lowest quoted price, in TCC's sole discretion.

The proposal must have a cover letter that provides the name of a single person to contact for all information. Tribal Contractors will be required to have limited liability insurance through a licensed carrier(s) in the State of Alaska for no less than \$1,000,000, prior to the execution of any contract. ☐ PROJECT EXPERIENCE – Describe the expertise in the A) providing traditional healing
direct services to clients B) facilitating in traditional/healing spaces and/or preparation of
traditional healing education/outreach materials, curriculum, etc
☐ TRIBAL INVOLVEMENT – Describe experience working with tribal governments or
TCC or other Alaska Native organizations, nations, tribes, or communities, and examples of Alaska Native or American Indian involvement on previous projects, and
☐ REFERENCES – Provide references and contact information for previous clients (ideally

☐ CAPACITY – List availability of designated staff and resumes, including copies of
licenses/certifications for all staff. A list of traditional/cultural skills
a. For Traditional Services: staff capacity and availability to see clients on
weekly/monthly basis, location to provide services, knowledge/experience working
