Types of Proof That Must Be Attached to Energy Assistance Application:

- Adult Public Assistance Benefits (APA)
- Alaska Temporary Assistance (ATAP) Benefits
- Alimony and Child Support
- Bank Statement
- Cash-out of Retirement or Pension
- Copy of last fuel or wood receipt or bill/statement
- Copy of Photo ID for applicant (acceptable forms of ID: Tribal ID, driver's license, state ID, passport)
- General Assistance (GA)
- Rental Income
- Retirement Benefits
- Self-Employment (Self Employment Income Report Form or Tax Return)
- Social Security Benefits Letter
- Student Loans, Student Grants, etc.
- Temporary Assistance (TA) Benefits
- Tips or Gratuities
- Unemployment Checks (approval letter, monetary determination letter)
- Veteran's Benefits
- Wages (a copy of last month's paycheck(s) Or Attached Work Statement Filled out by Employer)
- Workers Compensation
