

## TCC GO (Growing Our Own)

TCC GO is dedicated to helping Alaska Native students leave high school with a career plan and knowledge of post-secondary education and vocational training opportunities. TCC GO participants will learn what options might be the best fit for their interests and how to pursue them. While TCC GO focuses on encouraging students to enter a health-related field, our Student Support Coordinators and staff will work with students to develop a plan regardless of their career interest.

### Who should apply to TCC GO?

- Alaska Native students interested in getting a head start on their career or college/technical program of study.
- Students that are college ready and prepared to meet the challenges of dual credit courses.
- Students interested in exploring various career options.

### How to apply?\*

\*We encourage students interested in taking dual credit courses with UAF to apply before the start of the semester so we can process any tuition payments before classes start.
