

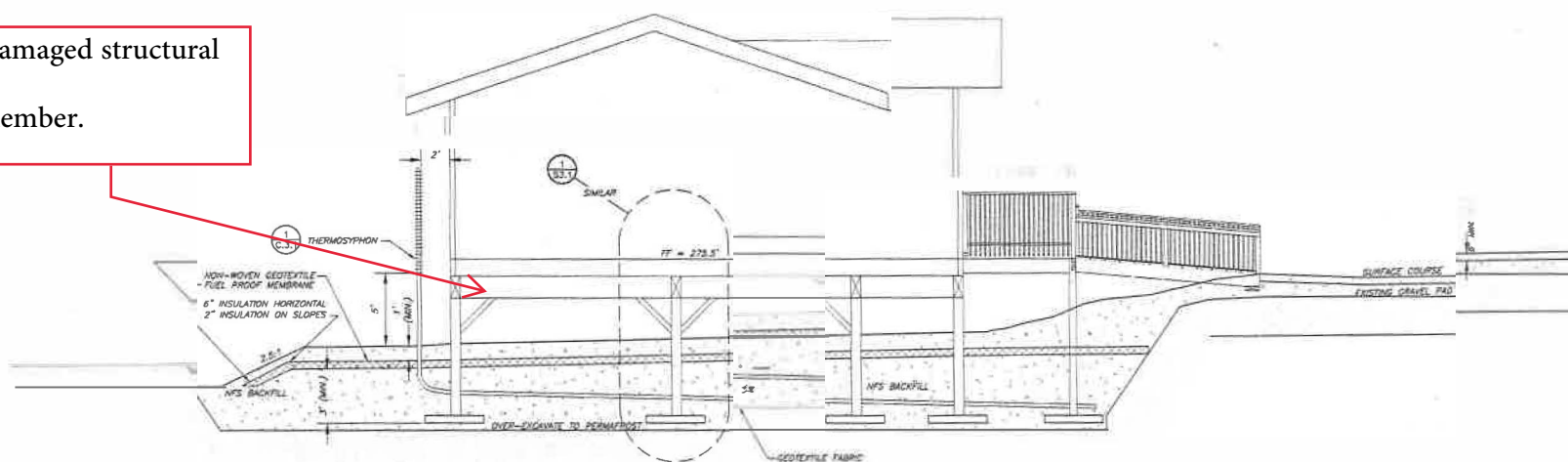
REPAIR FREEZE DAMAGE AT THE HUGHES CITY CLINIC RFQ ADDENDUM #2

April 11, 2024

1. The Contractor will provide temporary repairs to the structural member identified in Addendum #2 Appendix as detailed below.
2. The identified damaged structural member will be re positioned in its original location.
3. The repair will be made using two (2) ½" steel plates. The steel plates will be located on opposite sides of the vertical face of the damaged beam.
4. The plates will then be through bolted to the existing damaged structural member.
5. The plates will be a minimum of 75% of the length of the beam.
6. The Contractor will provide and install a new wooden structural member of the same size and type as existing.
7. The contractor will level the clinic within 1" of level along both axis.
